Subject: Non-reimbursement of CGHS contributions (fees) paid by BSNL pensioners as one time measure and non-settlement of long pending medical claims of BSNL pensioners -reg.

Respected Sir,

We would like to draw your kind attention towards the non-reimbursement of CGHS contributions (fees) paid by BSNL pensioners as one time measure in lieu of BSNL MRS and non-settlement of long pending medical claims of BSNL pensioners. In accordance with our discussions regarding abnormal delay in the payment of BSNL pensioners medical claims, your good self-advised us to convince the BSNL pensioners to opt CGHS facility instead of BSNL MRS and gave assurance that you will direct Circles to settle all the pending CGHS contributions (fees) claims within a period of two months. Accordingly, we advised BSNL pensioners to opt CGHS facility instead of BSNL MRS and many BSNL pensioners have now-opted CGHS facility wherever it is available by paying CGHS contributions (fees). More than two months have been passed but their CGHS contributions (fees) claims have not been settled by the Circles. It is learnt that Telecom Circles have issued sanction memos for reimbursement of CGHS contribution but not entered into the system for final payment. Circles are waiting for an instruction from BSNL Corporate office for the mode of payments.

The similar is the situation for non-payment of Medical claims of BSNL pensioners which are pending for the last two years for payment. Moreover the TDS against these medical bills has been deducted by circles but claims are not settled.

We would, therefore, request your good-self to kindly intervene in the matter and issue necessary instructions to all the Circles and BSNL Corporate office to settle all the medical claims and CGHS contribution paid by them at the earliest. We will be highly grateful to you.
