Sub:- Refusal by CGHS empanelled hospitals for cashless treatment to CGHS beneficiaries - regarding.

Respected Sir,

We would like to bring to your kind notice that our BSNL retirees en-mass had opted and joined CGHS, leaving their BSNLMRS health scheme, having a confident notion that they will get a dependable Central Government Health scheme coverage, post retirement for medical benefits for self and their dependents.

Further, additionally huge no. of BSNL staff and officers has also joined CGHS, after their retirement as on 31st January 2020 under VRS scheme, as our Association pleaded & pursued with them for it as a better Health scheme available.

But, we are sorry to state that since the outcome of Covid-19, now most of the CGHS empanelled hospitals in & around Kolkata even B.M. Birla Cardiology & R.N. Tagore Cardiology refusing admission to CGHS beneficiaries on cashless basis. Rather, they are asking poor pensioners to get admission on cash basis and submit bills to CGHS authorities afterwards for its re-imburement.

Now, the state of affairs have so much deteriorated that, even for outdoor treatment they are not giving appointments on current dates, forcing CGHS beneficiaries to wait for months or to get treatment outside.

Under these circumstances, we would, therefore, request your good self to kindly intervene in the matter and direct the concerned CGHS officers to inspect these empanelled hospitals and ensure that, the treatment to the CGHS beneficiaries are extended as per CGHS guide lines.
