Respected Sir

We have received 'Record of Discussion' of the meeting held on 17.10.2022 under the Chairmanship of Member (S), DCC, DoT. We express our sincere thanks for the same.

By and large it reflects the facts. But we are constrained to point out certain facts which are not reflecting in letter and spirit in 'RoD'.

- 1) The Associations have requested for supply of 'power point presentation' clips along with the 'minutes' because all could not study through screen in short time. But they are not attached. They may be sent on mail.
- 2) Though Member (S) told in clear terms that pension revision is de-linked from pay revision, it is not reflecting in unambiguous terms in RoD.
- 3) 9 (nine) associations and not 6 (six) submitted the memorandum.
- 4) The official side informed that various CAT judgements have ruled that the officers having opted and taken benefits of IDA, cannot claim CDA benefits. But 9 associations have pointed out that there are judgements from constitutional courts which stated that the combined service pensioners who opted for government pension should be treated at par with C.G pensioners.
- 5) 0% fitment was opposed by all the associations in one voice and Member (S) told that it would not be pursued further. He further informed that it would neither be 15% nor zero percent but in between. It is not possible to tell the actual percentage without consulting the Secretary and Hon MoC.

May we request you, sir, to modify the 'RoD' accordingly.
