We would like to draw your kind attention towards the non-availability of module in SAMPAN for the portability of PPO from one Circle to another Circle as available in general ie., if any pensioner wants to change their residence from the existing place (State) to other state. It was given to understand that, the issue is pending at Member (F) DoT.

This will help many retirees who retired at other than their home state and getting pension from the retired place which may be another state than of his home state. For example: a pensioner retired from the jurisdiction of CCA Maharashtra and after his retirement, he is residing under jurisdiction of CCA Telangana, etc.

We would, therefore, request your good self to kindly intervene in the matter so that the necessary additions may be made in the module of SAMPAN for portability of PPO from one Circle to another Circle, as available in the case of general retirees and drawing the pension other than from SAMPAN.
