**Sub: Non-reimbursement of Telephone bill Claims and Medical claims of BSNL CO employees -reg.**

**Respected Sir,**

We would like to bring to your kind notice that the Telephone bill Claims of BSNL CO employees are due for reimbursement for the period Jan.-2019 to Dec-2019 and same is the status of the employees of other Units who are residing in MTNL Delhi and Mumbai Area. Telephones bill claims for the quarter ending March-2020 could not be submitted due to ongoing lockdown situation.

As the merger of both BSNL and MTNL is the decision of the Govt. as reforms, the telephone bills being paid by the employees of BSNL and MTNL of both the PSUIs residing in BSNL/MTNL Area which should be immediately stopped once for all and DoT Status / Policy should be followed to avoid this Telephone claims reimbursement procedure. This is the problem being faced by the employees of BSNL residing in MTNL Area and vice versa.

2. Similarly, the medical claims reimbursement are not being settled since April-2019 in BSNL CO and in the Telecom Circles these are pending for the last three years which has caused serious hardship to the BSNL retired employees.

We would, therefore, request you to kindly intervene in the matter so that reimbursement of pending Telephone bill Claims and medical claims are settled at the earliest to avoid the hardship of BSNL retired employees.
