**Subject:- Welcome and Felicitation on assuming the high office of Minister of Communication.**

Hon'ble Sir,

We on behalf of All India Retired BSNL Executives' Welfare Association welcome and felicitate your kind honour on assuming the high office of Minister of Telecommunications, Govt. of India. We are confident that under your dynamic and experienced leadership Telecom industry of our country will progress further.

All India Retired BSNL Executives Welfare Association (AIRBSNLEWA) is representing majority Retired Executives and Non Executives of BSNL. At present the BSNL and MTNL pensioners are seriously frustrated and feeling ignored due to their Pension revision has not taken place for the last 7- years i.e. from 01-01-2017. These BSNL and MTNL pensioners are governed by CCS Pension rules-1972. Thus, the Pension of these BSNL and MTNL pensioners should have been revised with effect from 01-01-2017 along with their counter parts pensioners in the Government of India. But, DoT officers with a biased and prejudice attitude not settling the issue. Under the compelling circumstances we have filed a case in the PBCAT New Delhi and the judgement was given on 20.9.2023 in our favour as given below:-


**The judgement is mentioned as under for ready reference:**

*"In view of the elaborate discussion above, the OA stands allowed. The competent authority amongst the respondents is directed to forthwith revise the pension and family pension wherever applicable, strictly in accordance with the relevant rules and the entitlement governing pension to various sets of employees of the Central Government, maintaining strict parity. It is clarified that the benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the Pay Commission, shall stand extended in favour of the applicants, analogous to the revision of such pension in case of Central Government pensioners."*

DoT, instead of implementing the above judgement preferred to filed a writ petition in the Hon. High Court, New Delhi and denying justice to the senior citizens.

We would therefore, humbly request your kind honour to intervene in the matter and to direct the concerned officers DoT to implement to PBCAT New Delhi Judgement so that, pension revision of BSNL/MTNL pensioners with effect from 1.1.2017 is settled at the earliest.
