We, the All India Retired BSNL Executives' Welfare Association is one of the largest association working for the welfare of the BSNL pensioners would like to bring the following facts on the above subject matter to your kind notice for a favourable and immediate consideration and implementation.

Kindly refer to our letter dated 23.5.2024 and 12.9.2024 referred above on the subject matter of Commutation of Pension.

In this connection, it is to state that various courts had already issued stay orders to stop recovery on the above subject and has stopped recovery of Commutation from pensioners after 10 years and 8 months.

In the light of above, we the AIRBSNLEWA requests your goodself to kindly implement the judgement and arrange the re-fixation of the commutation factor and tables with retrospective effect from 1.4.2013 and render justice to the Pensioners by stopping the recovery of commutation amount after 10 years and 8 months, as done by various ministries and departments and render justice to the senior citizens, so that further litigations in this matter can be avoided.

It is pertinent to mentioned that immediate implementation of the naturally justified decision by your honour can avoid various legal cases / litigations by the pensioners of DoT/BSNL, which can not only save hard earned money of the pensioners but, the ex-chequer funds too.

It is once again requested to consider the matter favourably please.
