

Sub: Overcrowding in the counters for enrollment at CGHS HQ Kolkata

Respect Sir,

This is to inform you that consequent upon allowing the BSNL Pensioners for CGHS facilities and due to nonpayment of Medical Claims by BSNL since last two years, All BSNL pensioners are now migrating to CGHS. Additionally about 5 thousand BSNL employees stationed at Kolkata and around will be retiring on VRS on 31st January 2020. It is expected that all of them will be migrating to CGHS due to uncertainty of payment of BSNL medical scheme. BSNL management is also encouraging its retirees to migrate to CGHS in view of acute financial crisis in BSNL.

As a result the counters of your office for enrolling the pensioners are very much overcrowded. Pensioners going for collecting forms and for submitting filled up forms are facing very inconvenience as they have to wait for long hours. The situation will further worsen after 31st January 2020 for the reason explained above.

We therefore request you to take suitable measures to provide more convenience to the pensioners. Your personal positive action to solve the problem as stated above is urgently solicited.

We also request you to grant us a meeting to discuss some issues related to various wellness centers of Kolkata for betterment of CGHS services.
