**Subject: Pension Revision of BSNL absorbed DOT Pensioners on IDA scales- abnormal delay by the field units is BSNL, Principal CCA and CCAs.**

Respected *Sir/Madam*,

The order for pension revision of BSNL absorbed DOT pensioners by merging 78.2% IDA from 1.1.2007 was issued vide DOT OM No. 40-13/2013-Pen (T) dated 18.7.2016. The target for completion was given as 31/12/2016 which was further extended up to 10.4.2017 as no CCA could complete the work up to 31/12/2016. Even that target is failed miserably and in many circles 30% work is still pending.

Sir we have requested you from time to time on 5/12/2016, 22/4/2017 and 2/5/2017 to expedite the pension revision (copies are at Annexure -I, II, and III). But after a lapse of 11 months of order dt. 18/7/2016, the work is still not completed. sir I met Sh. Pathak CCA New Delhi on 8/5/2017 and gave him a representation (copy at Annexure IV) for early issue of revise Pension orders of NTR BSNL CO.

Similarly a delegation of our Association office bearers of Nashik branch tried to meet CCA Maharashtra circle Mumbai but they were not allowed to meet CCA on the plea the staff AO/CAO were not available to give them information. Copy of letter addressed to CCA Mumbai is enclosed at Annexure - V.

The pensioners whose pension has not been revised are in a total helpless condition. Many pensioner/family pensioners are not able to go CCA office because of health problem and are in deep distress.

Hence we request you kindly instruct all CCA/Pr. CCA/CMD BSNL to complete this work without further delay. Thanks & Regards.

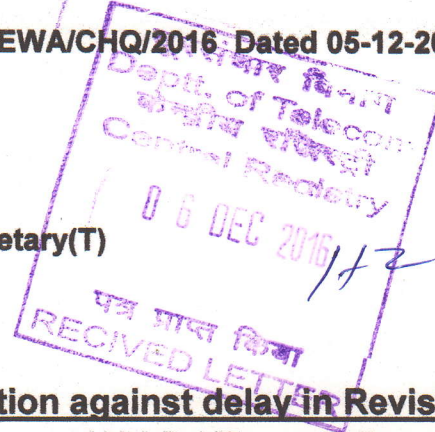

Respectfully, it is brought to your kind notice that Benefit of the Merger of 50% of IDA as on 1/1/2007, which was extended by Government of India to the BSNL Pensioners/ Family Pensioners, at par with BSNL Employees vide DOT OM No.40-13/2013-Pen(T) dt 18-07-2016. These orders approved extending the benefit of merger of 50% IDA amounting to 78.2% fitment as on 1-1-2007 to all pensioners retired before 10-06-2013, on notional basis w.e.f. 1/1/2007 to 09/06/2013, and payable on actual basis w.e.f. 10/6/2013. BSNL also endorsed the said order vide their OM No. 40-06/2011-Pen.(B)(Pt) dated 26-07-2016.

**TARGET DATE** set by DOT for implementation of these orders is **31/12/2016**. Majority of around 1.8 Lacs BSNL Pensioners/ Family Pensioners are still awaiting the receipt of their revised

PPOs from respective CCAs, and consequent payment of REVISED PENSION and arrears thereof arising out of 50% IDA Merger.

But even after a lapse of four and a half months of the issue of the orders dated 18/7/2016 out of around 1.8 lacs EX-DOT Employees retiring as BSNL Pensioners more than 85% of BSNL Pensioners / family pensioners have not yet received their revised PPOs. Around 1.53 lacs BSNL pensioners are still awaiting revision of their PPOs as on date to receive the benefits of orders dated 18/7/2016.

Kindly look into the matter and arrange for expeditious and timely revision of PPOs for payment of revised Pension/ Family Pension before 31/12/2016 as targeted / proposed by DOT in OM dated 18<sup>th</sup> July 2016 and the Cabinet decision preceding the same.




Such uncertainty has caused huge mental agony to the 1.5 lakh BSNL pensioners. Kindly realise Sir, the 78.2% IDA merger order for serving employees was issued on 10-06-2013. After 3 years the same order for pensioners issued on 18-07-2016. Now almost after 10 months only 50 to 60% cases are completed and it appears that the CCA offices will take several more months to complete the work. And pl remember Sir, this revision is being effected from 1-1-2007 as per 2<sup>nd</sup> PRC.

The pensioners, whose pension has not been revised, are in a total helpless condition. Many of them have lost their mobility and hence cannot go to offices for persuasion and hence are in deep distress.

We therefore request you to kindly instruct the CCAs to publish the list of Pensioners for whom the revision is pending along with a tentative target date in their website and in Notice Board. The CCAs may also publish periodical completion lists in the websites. In that case the pensioner can find his name and know the status and get some mental relief. While publishing the list the total list of Pensioners may be considered as per respective CCAs record. It will help in identifying the cases pending at BSNL end.


R/Madam,
